14. APPOINTMENT OF MONITORING OFFICER

1 Summary

- 1.1 The reports seeks to agree the appointment of Mr Stephen Rix as the Council's Monitoring Officer from 22 May 2023.
- 1.2 The appointment of the Monitoring Officer is a Council appointment by virtue of the Local Authorities (Standing Orders) (England) Regulations 2001 with the statutory powers being:
 - Under Section 5 of the Local Government & Housing Act 1989 (as amended), the Council has a duty to appoint a Monitoring Officer. Neither the Head of Paid Service nor the Chief Financial Officer can hold the position of Monitoring Officer.
 - The Monitoring Officer has a number of statutory duties and responsibilities relating to the Council Constitution and our arrangements for effective governance.
 - Article 4 of the Constitution provides that it is the responsibility of full Council to designate the Monitoring Officer.
- 1.3 The report also seeks to agree that any reference to Solicitor to the Council in the Council Constitution be amended to Chief Legal Officer.

2 Details

2.1 **Appointment of Monitoring Officer**

- 2.1.1 The Council's current Monitoring Officer, Ciara Feeney, appointment was made on an interim basis in May 2022.
- 2.1.2 Council will be aware that this is a statutory post and since the interim appointment was made have been undertaking a recruitment process to find a full time replacement.
- 2.1.3 Council are asked to confirm the appointment of Mr Stephen Rix to the role of Monitoring Officer. This is not a Chief Officer role (under Article 12 Officers, point 12.01) and therefore it is not a Member appointment however all the Group Leaders were invited to meet Mr Stephen Rix before a formal offer was made. The role of Monitoring Officer is a statutory post and requires approval by Council.
- 2.1.4 Approval is requested for the appointment of Mr Stephen Rix as the permanent Monitoring Officer and to request that reference to the Solicitor to the Council in the Council Constitution be amended to Chief Legal Officer.

3 Options and Reasons for Recommendations

3.1 The appointment of Mr Stephen Rix as Monitoring Officer be agreed from 22 May 2023.

3.2 That reference to the Solicitor to the Council in the Council Constitution be amended to Chief Legal Officer
