May Overview:

Increase in the number of frontline police officers

In 2018/2019, the number of actual officers has risen from 1,915 to 1,980 reflecting the Commissioner's commitment to supporting frontline policing. An additional 32 police officers have also been welcomed into the Constabulary for June, following the completion of their 16-week training and will begin to join the local policing teams they have been assigned to.

In the last year, the proportion of spend on frontline policing in Hertfordshire has been 72.1 per cent, higher than the national and most similar group averages. The Constabulary are continuing to recruit up to the establishment figure of 2,034 with regular intakes scheduled over the coming months.

Police and Crime Commissioner's Action Fund 2019/20

The PCC's Action Fund is currently accepting applications. Grants of up to £5000 are available to help support community and voluntary initiatives which will reduce crime and make Hertfordshire a safer place to live by helping to deliver the priorities of the Community Safety and Criminal Justice Plan for Hertfordshire (2017-2022). There will be three rounds where funding will be made available in 2019-20. The second round of applications will close on the 9th August 2019.

Using funds recovered under the Proceeds of Crime Act, the Fund empowers local groups to find solutions to community safety problems. The Commissioner is keen to work with and fund a range of organisations from the community who have a shared interest in delivering positive outcomes and improved services for residents.

Expansion of the PCC's Fly-Tipping Fund on Private Land

Using £20,000 set aside from the Proceeds of Crime Act (POCA), the Police and Crime Commissioner has recently introduced a pilot scheme to support landowners who have been victims of fly-tipping on their private land. The pilot follows a light-touch process, in asking district and borough councils to expand their existing service to include fly-tipping on specific types of private land and to subsequently pass the cost of this clearance onto the PCC. This work is supported by Hertfordshire's Fly Tipping Group, and is in line with their work programme, helping to improve knowledge in relation to fly tipping on private land, including the number and types of incidents occurring and typical clear up costs.

The pilot has recently been expanded into North and East Herts and approval has already been given for the clearance of a fly-tip in East Herts. With this expansion, the pilot is now in operation across six of the 10 districts; Three Rivers, Broxbourne, Welwyn Hatfield, St. Albans, North Herts and East Herts.

We would encourage all other districts and boroughs to be involved in the pilot so that we have a better understanding around the scale and nature of fly tipping on private land and are best able to support victims of fly tipping.

PCC's Rural Crime Survey

In April, the PCC launched his first rural crime survey for Hertfordshire residents. The survey aims to identify the perceptions of rural crime amongst Hertfordshire residents and the level of public confidence in how rural communities are being policed, building on the responses to the National Rural Crime Network's Survey conducted last year. Through this, the survey is expected to inform the development of future policy and practice, helping to guide the Constabulary's Rural Operational Support Team in setting the strategic direction for rural policing in Hertfordshire.

The response rate has been good so far, with over 600 residents providing their views, with a further month left to go before it closes on the 1st July 2019. Following its closure, the results of the survey will be analysed and subsequently published on the PCC's website.

OPCC awarded the Independent Custody Visiting Association Quality Assurance Silver Award

The Independent Custody Visitors (ICV) Scheme provides public and transparent assurance that the rights, entitlements, wellbeing and dignity of detainees in police custody in Hertfordshire is being maintained. It provides oversight and accountability, preventing the ill-treatment of detainees and ensures that a high-level of welfare is maintained.

In 2019 Quality Assurance awards were introduced by the Independent Custody Visiting Association (ICVA) to help schemes: reflect on how they comply with the Code of Practice, the legislation that underpins custody visiting, celebrate areas of strength and promote custody visiting.

Within each level, there were more than 25 sets of criteria covering key areas such as holding the force to account, and requiring evidence to support each assessment. For Silver and Gold levels, schemes had to get their submissions peer assessed, with ICVA assessing those submissions which had been nominated for a Platinum award. Hertfordshire were presented with the silver award at a celebratory event which took place at the House of Lords.

The OPCC are actively looking for new volunteers from all areas of the community to reflect the demographics of the county. It is an interesting and flexible role. Applicants do have to be over 18 years of age, have lived in the UK for at least three years and undertake police vetting. Bids accepted for the Road Safety Fund

2018/19 saw the launch of the third year of the Road Safety fund to help address community concerns across the county, supporting efforts to change drivers' attitudes and behaviours.

The Road Safety Fund invites local community groups and organisations to apply for funding to help develop and design local solutions where a need has been identified, supporting projects that will assist in the delivery of Hertfordshire's Strategic Road Safety Partnership's vision. The fund aims to develop new and innovative ways of improving road safety, supporting a holistic mix of engineering and education to achieve sustainable behaviour change solutions and interventions which focus on reducing road casualties and antisocial road use.

During 2018/2019, a total of **39** applications were received focusing on issues that matter to the public. This included speed compliance, casualty reduction, and anti-social road

behaviour. Of the 39 which were received, 24 have been initially approved of which 13 involve consideration relating to installation or movement of Speed Indicator Devices.

Criminal Justice Innovation Fund 2019/20

The Criminal Justice Innovation Fund has been extended into 2019/20 with the first round receiving five applications that will now be considered by the Hertfordshire Criminal Justice Board and subgroups. The fund is aimed at supporting improvements in the criminal justice

system for the people of Hertfordshire. The Fund was introduced in 2018/19 to support delivery of the Hertfordshire Criminal Justice Board's strategic objectives and to provide an opportunity to fund new and innovative projects or build on the success of effective and transferable interventions.

It is open to public and private organisations, criminal justice and community safety partners working in collaboration with the voluntary and community sector. Applications can be made to the fund that seek to: support new activity; develop an evidence base; or run a project / pilot; show sustainability beyond the life of the funding; show evidence of support and is realistic, deliverable, financially viable and demonstrates value for money.

The next deadline for applications within round two is Friday 21st June.

In 2018/19 projects that received funding included; a rent deposit scheme for those starting their life away from crime, a support project for those within the criminal justice system with gambling addiction and a domestic abuse perpetrator project.

Local Partnership Reserve: Funding to Support Crime and ASB Reduction Initiatives 2019/20

In October 2016 £400K was made available by the Police and Crime Commissioner to assist community safety partners to respond to nuisance crimes including ASB, fly-tipping and fly-grazing. A further £100K for this final year during 2019/20.

Applications must:

- 1) Demonstrate a problem solving approach using O'SARA and with due consideration to the victim, location and offender;
- 2) Relate to a current Community Safety Priority;
- Clearly show how the community is involved in identifying what is happening, why it
 is happening and in determining the response(s) to which the application relates,
 and;
- 4) Support a response to tackle nuisance or anti-social behaviour and associated crime (and includes fly-tipping, fly-grazing and other environmental issues).
- 5) Provide 'matched' (or contribution) funding to ensure that there is joint ownership of the issues the funding is seeking to tackle
