#### PR131/16 EXEMPTION FROM PROCUREMENT RULES

The report advised Members that an exemption to the Procurement process was required to purchase ultrasound units for use at the Aquadrome to prevent blue-green algal bloom.

In response to Member questions on the procurement of the units, the Committee noted that the supplier of the units was known to Officers before they were directly approached.

#### PR132/16 EXCLUSION OF PRESS AND PUBLIC

### PR133/16 PROPERTY BUSINESS PLANS AND CASES
