Photo evidence of party goers cars jammed, parked in our road can be given (this was after they had removed cars and removed them).

On atleast 2 of the evenings police had to block the road due to the number of people from event stood in old mill Road.

The sound level was excessive and went on until very late on one of the occasions it was a Sunday after the European Championship final. Many of us have to get up for work.

On all three occasions many cars were jammed packed in our road even to the extent of removing cones from the entrance road throwing them behind a hedge and parking there anyway. This made it very difficult to get out of the maltings by car, and even if you could the police had to block old mill Road for safety reasons.

On one occasion I was returning from a night out and was kept waiting in my car outside Riverside mensions while the police tried to disperse the people and cars from the venue. This took me 30 mins to travel 500 metres to get home.

Security people could be seen at the bottom of our road not only was this intimidating but they did nothing to disperse the traffic.

When my partner went to complain about the noise a bouncer told her to go away and stand on her foot.

None of us thought our homes here expecting our street to be used as a car park for a glorified night club.
