# 7. RICKMANSWORTH PARK PLAY AREA (DCES)

# 1 Summary

1.1 The purpose of this report is to assess whether or not Rickmansworth Park would be a suitable location for a play area. In addition the report considers use of Section 106 funds for additional play facilities within Rickmansworth Aquadrome.

#### 2 Details - Rickmansworth Park Play Area

- 2.1 At the Leisure, Environment and Community Committee on 11 July 2018, Members requested officers investigate the viability of an additional play area at Rickmansworth Park (LEC 07/18).
- 2.2 Officers subsequently arranged to meet with the Design Out Crime Officer, from the Crime Prevention Design Service at Herts Constabulary as well as the Grounds Maintenance team on site to explore this option.
- 2.3 The full details from the Design Out Crime Officer can be viewed at Appendix A. In summary, the Officer confirmed that they would be unable to support this proposal for various reasons, including:
  - Anti-social behaviour
  - Drug use
  - History of several serious assaults at the location
  - No natural surveillance
  - Not accessible for emergency vehicles.
- 2.4 Grounds Maintenance confirmed that they would be unable to support the proposal, citing similar concerns to the Design Out Crime Officer as well as stating that during the winter months their vehicles would not be able to get to the site in order to carry out any maintenance or repairs.
- 2.5 In addition, the area already has three substantial play areas for the local community, namely Scotsbridge play area, Ebury play area (Rickmansworth Aquadrome) and the newly refurbished Skidmore Way play area.

#### Details - Rickmansworth Aquadrome - additional play facilities

- 2.6 In order to enhance the play offer at Rickmansworth Aquadrome, Officers propose utilising £12,596 of Section 106 funding to install a Wildwood Den in the dog-free picnic area during the financial year 2019/20 (see appendix B for location details and appendix C for examples of Wildwood Dens).
- 2.7 The play space would be designed to be in-keeping with the local area and provide families with a playable feature when accessing the dog-free picnic area. It would be sited carefully, taking into consideration the Rickmansworth Canal Festival and access into the area.

2.8 The Section 106 funds, which are proposed to be used for this project are: The Coach House, Rickmansworth (£7,676) and 18-26 Ebury Road, Rickmansworth (£4,920).

# 3 Options and Reasons for Recommendations

3.1 The purpose of this report is to assess whether or not Rickmansworth Park would be a suitable location for a play area. In addition the report considers use of Section 106 funds for additional play facilities within Rickmansworth Aguadrome.

- 4.2 The impact of the recommendations on these performance indicators is that they will support the Council in achieving these targets.

# 5 Financial Implications

5.1 Funding for the Wildwood Den at Rickmansworth Aquadrome would be through the Section 106 funds as detailed at point 2.8.

# 6 Legal Implications

- 6.1 Section 106 monies to be used are specifically for providing and improving amenity space, as well as children's play equipment. The use of section 106 monies for the projects set out in the report would be in conformity with the Section 106 deeds which secured it.
- 6.2 All proposed works will be tendered within the Council's Constitution and procurement procedures.

8.1 The small leisure facilities capital programme will require the time of the Leisure Development Manager, Projects Development Officer, external Principal Designer and Project Manager to oversee project management, consultation, negotiations and installation of the new facilities.

# 9 Environmental Implications

9.1 The play space will utilise natural, raw, untreated and sustainable English Oak, sourced from a location with a sustainable forestry management plan and ideally sourced locally.

9.2 In addition, the natural play space will create a new habitat for insects and other minibeasts.

# 10 Community Safety Implications

- 10.1 The local Police Community Safety Officers, Crime Prevention Liaison Officer and the Grounds Maintenance team will be consulted on the final design options for all sites.
- The installation of new leisure facilities will provide the opportunity for children and young people to take part in positive activities.

# 11 Public Health implications

11.1 Providing free, accessible play facilities will encourage children and young people to be physically active, and will support the achievement of the Council's Physical Activity Strategy. It will also provide a point for families to meet and socialise, supporting mental wellbeing and the priorities of the Hertfordshire Health and Wellbeing Strategy.

#### 13 Communications and Website Implications

- 13.1 Officers will work with the Trees and Landscape department, Park Ranger, café owner and any other stakeholders on the development of the play space at the Aquadrome.

- 13.3 In addition, Members will be updated as work progresses.

- 15.2 The Leisure, Environment and Community Committee agree to use the Section 106 funds, detailed at point 2.8 to install an additional play space in the dog-free picnic area at Rickmansworth Aquadrome, during the financial year 2019/20.
