Dear Sir/Madam,

I would like to lodge my objection to the application for a late licence and music at the Masala Bowl Restaurant in Rickmansworth.

I live in the flat opposite (above Starbucks) and my bedrooms all face directly to the restaurant. Since opening they have already had loud music on a number of nights and it is really disruptive. Not just the music but the doors constantly opening and people gathering loudly on the pavement outside.

They have been displaying a sign outside saying "Every Friday Night DJ Set" - whereas my understanding is that it is a restaurant licence they have been granted.

I don't understand the licence for alcohol on and off the premises. They do not have any outside space so would this mean people drinking on the pavement?

Having been born in Rickmansworth I believe it is trying hard to retain some of its charm and character and I don't believe a late licence with music is appropriate. There are places nearby, such as Watford, where people can go for late drinks and music - it is not necessary in Rickmansworth. I remember back when a similar licence was granted to 92s in the same building - and it caused a lot of problems and complaints.

Objection to application for variation of premises licence - Masala Bowl Ltd., 92 High Street, WD3 1AQ

Dear Licensing Team

I note the recent application by Masala Bowl Limited at 92 High Street, for a licence until 1.00 a.m., to sell alcohol, provide food and play music.

[REDACTED]
The Ebury View flats are directly across the road and opposite 92 High Street.

I would like to object to the application to play of loud live and recorded music until 1.00 a.m. in an area where there is a significant amount of residential accommodation - based on Masala Bowl's use of loud music in the past, which has disturbed those living nearby, the use of any such licence (if approved) is likely to prove anti-social for neighbours, disruptive of sleep, and disruptive of neighbours' right to peacefully and quietly enjoy living in their home.

Furthermore, a 1.00 a.m. licence for music seems excessive for what is a local Rickmansworth restaurant, not a music venue such as a stadium in a large city.

I hope you will strongly consider noise pollution issues when assessing this application, and the rights of Rickmansworth residents to quietly enjoy and peacefully their home.
