## Minute PR94/20 - ADOPTION OF LOCAL GOVERNMENT ASSOCIATION MODEL COUNCILLOR CODE OF CONDUCT 2020

Councillor Sarah Nelmes moved the motion saying the new code appeared to be a better version of the previous code and that most of the existing Councillors had received training for the new Code.

Councillor Alex Hayward seconded the motion, saying the training showed that the code covers every area, was pleased that the register of gifts had remained unchanged at  $\pounds 25$ , and encouraged all Councillors to register any gifts they received from companies within this District.

On being put to Council the motion was declared CARRIED by the Chair of Council the voting being by general assent.

#### **RESOLVED**:

- 1. That the Council adopts the Local Government Association Model Councillor Code of Conduct 2020 with effect from this Annual meeting in May 2021.
- 2. Agreed that the limit for registering gifts and hospitality remain unchanged at £25.

- 3. That all Members should have attended one of the 3 training sessions on the Model LGA Councillor Code of Conduct which is essential training for all Members prior to adoption of the code.
- 4. That additional training be arranged after the 2021 elections on the Model Councillor Code of Conduct for any new Councillors and that they be required to attend in accordance with the provisions of the Code.

## Minute PR96/20 - CLIMATE EMERGENCY AND SUSTAINABILITY STRATEGY 2021-2026

Councillor Phil Williams, seconded by Councillor Matthew Bedford, moved the recommendations.

Councillor Reena Ranger asked the Lead Member how the Climate Change Strategy and the Local Plan worked together, as it was disappointing that this strategy didn't mention the Local Plan. It would also be good if some timelines were included in the strategy. Councillor Ranger wished to congratulate residents on their help in ensuring the Council met its recycling targets.

Councillor Matthew Bedford said these points would be picked up when the item on the Local Plan was debated.

Councillor Paula Hiscocks asked the Lead Member to advise how much expense had been budgeted for, how we would be paying for this wonderful new strategy, and how many new grants we had applied for so far so it's not residents paying for all of this. The Lead Member, Councillor Williams, agreed to provide a written reply.

## Written response provided by the Lead Member for Environmental Services, Climate Change and Sustainability:

At present we have an annual budget of £30,000 in the Community Partnerships Team to deliver initiatives and some elements of the Strategy. The Council are also seeking grant opportunities when possible to deliver the plan as well as drawing in match funding from partners. To date we have secured Green Homes Grant funding to retrofit approximately 250 homes in Three Rivers. A third fund will be available shortly for another 35 homes. We are preparing to bid for another round of funds in August for work in 2022. Our share of these grants is almost £1.5million. We have also applied for two other grant opportunities through the National Lottery and the Decarbonisation Fund with the Department for Business, Energy and Industrial Strategy (BEIS) which we have not been successful with yet, however is helping to prepare for future bids and the next round. The Strategy is being delivered across all services at the Council and a number of actions will be delivered in partnership with other organisation and with community groups.

On being put to Council the motion was declared CARRIED by the Chair of Council the voting being by general assent.

#### **RESOLVED**:

That the Climate Emergency and Sustainability Strategy is agreed for adoption.

# Minute PR98/20 - CORPORATE PLAN AND FINAL SERVICE PLANS 2021-2024

Councillor Sarah Nelmes moved, seconded by Councillor Stephen Giles-Medhurst the recommendations.

On being put to Council the motion was declared CARRIED by the Chair of Council the voting being by general assent.

## Minute PR99/20 - BUDGET MONITORING – MONTH 10 (January)

Councillor Matthew Bedford, seconded by Councillor Sarah Nelmes moved, the recommendations within the report.

Councillor Paula Hiscock's said they were aware Three Rivers District Council had received sums of money from the Government for 'Reopening the High Street' as a 'Welcome Back' fund to increase the look and feel of the High Street. This wasn't evident in the report and could Ward Members be consulted in its spending.

Councillor Matthew Bedford said that this report was up to the end of January so the monies mentioned would be found in a future budget monitoring report.

Councillor Alex Hayward asked for an update on Jigsaw income.

## Written response provided by the Lead Member for Resources and Shared Services:

For 2020/21 we received £9,911. For 2021/22 we have received £3,624 to date, however we invoice for the 11% turnover related element of rent quarterly in arrears so that is not yet due.

On being put to Council the motion was declared CARRIED by the Chair of Council the voting being 19 For, 0 Against and 14 Abstentions.

## Minute PR103/20 - LOCAL PLAN SUB COMMITTEE RECOMMENDATIONS

Councillor Alex Hayward declared a pecuniary interest in the recommendation and left the meeting during the consideration of this item.

Councillor Matthew Bedford moved the substantive recommendation, and an amendment to the recommendation as follows:

- 1. To amend the recommendations of the Local Plan Sub-Committee and Policy & Resources Committee as follows:
  - a. Omit the 'contingency' sites which are not required to achieve the target numbers;
  - b. Omit sites CFS21 & CFS26a which would cause particular harm to existing communities and residents' quality of life without providing compensating benefits to the community;

- 2. To work with local Residents' Associations, Parish Councils and others to continue to press the government for a reduction in the government's target for the number of homes to be built in Three Rivers and for additional powers to determine the mix and tenure of new homes in order to better meet the needs of local people;
- 3. To regularly inform all residents of the Council's proposals and progress.
- 4. That delegated authority be granted to the Head of Planning Policy & Projects and the Director of Community and Environmental Services in consultation with the Leader of the Council and Lead Member for Planning Policy to make the necessary changes required as a result of this motion before the documents are published for consultation.

Councillor Matthew Bedford stated that Three Rivers District Council was required to produce a Local Plan to provide a framework for the future physical development and infrastructure of the District, and that we are obliged to do this in line with guidance from national Government. Ministers had repeatedly made it clear that the Local Plan should be formed to our specific local needs and circumstances. Tensions and opposing objectives are faced as new homes are needed and both young and old need suitable properties; Key workers should not be made to commute for miles to work in the area. There was a realisation that development was needed, but also that the green spaces in the District are essential. The Local Plan was more than a list of sites and contained some important policies that will impact on the whole District, and sets out a vision for the area. The target for the District was calculated according the Government standard methods which had seen our numbers increase significantly, from 180 homes a year to over 600 homes a year, which was based on out of date information. The Government had the opportunity to work with more recent data but chose to use old information. There had been assurances that this was a starting point and not a target or a minimum, and the plan was set by us as a Council. The amendment recognised that if enough sites are allocated to meet the target we would cause serious harm to existing communities. This was the first time the Council was promising a total number of homes which was lower than the Government's standard calculation which may need to be justified to a Government Inspector. The list of sites is not fixed and will be reviewed in light of the results of the consultation. Every community in the District will be affected by this in some way so everything will be done to ensure people in the area know what is happening and how they can comment.

Councillor Sarah Nelmes seconded the substantive recommendation and the amendment.

Councillor Stephen King stated that they were very nervous with sending a Local Plan out to consultation that does not meet the Government's, admittedly outrageously high, housing targets. They asked if the administration had consulted with neighbouring authorities on the amendment, and how many other authorities will not meet their target.

## Written response provided after the meeting by the Lead Member for Infrastructure and Planning Policy

The Council has approved our amendment to reject certain sites as housing allocations. By doing so, we have chosen not to accept the Government's 'standard method' for calculating future housing provision. While there is a need to provide for new homes in the District, we do not accept that this should be at the expense of the wellbeing and quality of life of existing residents. Officers and Members will continue with the Duty to Co-operate meetings with neighbouring authorities as the process continues and this will include taking account of the results of the Regulation 18 consultation.

Watford and Dacorum have both consulted on local plan documents that seek to meet their housing targets; Hertsmere and St Albans are yet to publish their local plan documents so we are unable to determine whether or not they will be meeting their housing targets at this time.

Councillor Lisa Hudson asked if the decision to remove the two sites was made by elected Members or Officers, and if by Members who was involved?

Councillor Shanti Maru asked what was the criteria used to remove the two sites in Croxley Green and Abbots Langley?

Councillor Donna Duncan asked why the criteria used to take out the two sites was not used equally across significant Green Belt sites?

Councillor David Coltman asked if Council can be assured that there will be no more changes to sites under delegated powers and that residents will be consulted on all other sites?

Councillor Paula Hiscocks asked whether changes and increases to the Batchworth Golf Club and Maple Cross sites were made under delegated powers, and when was Chorleywood and Green Street removed from the Local Plan? Could a full schedule of amendments be provided?

Councillor Ciaran Reed asked why was the Local Plan published after the recent election, would the list of documentation released include the stage two Greenbelt assessment, and who will write and approve the contents of any leaflet?

Councillor David Raw was concerned that the library was included.

Councillor Reena Ranger said that the administration had failed to deliver on housing targets and now sites were being cherry picked, saying that a decision needed to be made so residents can have their say.

Councillor Reena Ranger proposed the following amendments:

No further delegated powers;

include a sustainability statement and a framework so residents can fairly measure each site, and one site against another, and to include a Green Belt review document so that classification for each site can be understood.

This amendment was seconded by Councillor Paula Hiscocks.

Councillor Phil Williams said that the library would remain, and if required housing would be built above it. Green Street was not in the Local Plan, and it was nearer 2,000 homes being built in Maple Cross, not 1500. Councillor Williams would be lobbying Councillor Matthew Bedford to reduce these numbers, noting Sarratt and Chorleywood North were barely touched in the Local Plan.

Councillor Stephen Giles-Medhurst said that one of the reasons the Local Plan was delayed was in order for a review of all the Green Belt sites to take place and to look at the impact, which was agreed by all members of the subcommittee. Leavsden had changed dramatically over the last 25 years and sites in this plan are likely to be built on, which had to be accepted. 72% of Three Rivers is Green Belt so building solely on brownfield sites doesn't assist in getting near to the Government target. MPs had the opportunity to object to the housing numbers which would have benefited nine out of the ten Authorities in Hertfordshire. In order to get this right MPs and residents need to be on board with these housing targets. The Council will consider the responses to the Regulation 18 consultation and take them on board. Councillor Giles-Medhurst welcomed hearing from the public, and hoped that all Members would try and persuade their MPs that the figures for Three Rivers were wrong, and some of these sites do not need to go forward as a result.

Councillor Sarah Nelmes formally seconded the substantive recommendation and the amendment to the recommendation saying the Local Plan looked to positively meet the figures set by the Government, taking into account the limitations of the sites available. The District requires good housing and more of it, and needed more than what can be built on brownfield sites and on town centre land. The Local Plan contained possible sites for development which would now be consulted on.

Councillor Matthew Bedford did not accept the amendment put forward by Councillor Reena Ranger stating that the stage two Green Belt assessment and sustainability assessment were shown within the original recommendation from the Policy and Resources Committee and that no changes had been made under delegated powers.

Councillor Matthew Bedford reiterated the documents requested would be included, and the library would be remaining in its location.

On being put to Council the amendment to the substantive recommendation was declared CARRIED by the Chair of Council the voting being 27 For, 0 Against and 5 Abstentions.
