10. MINOR AMENDMENT TO PART 2 OF THE COUNCIL CONSTITUTION – ARTICLE 14 – POINT 14:05 (CED)

1 Summary

1.1 This report is being brought to Annual Council to agree a minor amendment to Part 2 of the Council Constitution, Article 14, Point 14:05.

1.2 Article 14, Point 14:05 currently states the following:

14.05 Common Seal of the Council

The Common Seal of the Council will be kept in a safe place in the custody of the Solicitor to the Council. A decision of the Council, or of any part of it, will be sufficient authority for sealing any document necessary to give effect to the decision. The Common Seal will be affixed to those documents which in the opinion of the Solicitor to the Council should be sealed. The affixing of the Common Seal will be attested by the Chief Executive, Director of Finance, Director of Community and Environmental Services or the Solicitor to the Council.

During the Covid 19 pandemic any of the following officers are also authorised to attest the seal:

A Principal Solicitor, Principal Lawyer of the Council, Emergency Planning and Risk manager”

1.3 Council are asked to agree to removing the words “During the Covid 19 pandemic” with the wording of Point 14:05 to read:

“Any of the following officers are also authorised to attest the seal:

A Principal Solicitor, Principal Lawyer of the Council, Emergency Planning and Risk manager”

1.4 Council are asked to also agree to continue to allow the additional officers to attest the seal.

2 Details

2.1 The reason for the report coming to Annual Council is that with the Government now removing Covid-19 restrictions in England, from April 2022, the wording “during the Covid 19 Pandemic” is now no longer required and not relevant.

2.1.1 The Senior Leadership Team wishes to continue with the authorisation of other officers to attest the seal as it provides for more resilience in being able to get documents sealed promptly and within legal timeframes.

3 Options and Reasons for Recommendations

3.1 To agree the minor amendment to Article 14, Point 14.05 as detailed at Paragraph 1.3 and that the Council Constitution be updated accordingly.

3.2 To agree to continue to allow the additional officers to attest the seal.
