6. GREEN EXPECTATIONS – SUSTAINABILITY AND CLIMATE CHANGE STRATEGY AND ACTION PLAN 2018-19 (DCES)

1 Summary

1.1 The Green Expectations strategy for Three Rivers was published in March 2015 and set out aims and objectives for the authority on sustainability and climate change. This report sets out progress against the Action Plan for 2017-18 to help achieve these aims and objectives and sets out actions for 2018-19.

2 Details

- 2.1 In March 2015 Three Rivers District Council published a Sustainability and Climate Change Strategy, Green Expectations. This set out the environmental and sustainability aims and objectives for the next 5 years. In order to achieve these objectives an Action Plan is published each year to set and monitor targets to meet the aims and objectives.
- 2.2 The strategy and action plan was divided into 8 broad themes:
 - Energy and Climate Change;
 - Biodiversity;
 - Waste;
 - Reducing Water Use;
 - Flooding;
 - Sustainable Transport;
 - Sustainable Procurement and Fair Trade; and
 - Climate Change Adaptation.

It also considered the cross-cutting themes of economic development, partnerships, inclusion, education and promotion, and health.

2.3 Under each of the broad themes the strategy set out a key aim. In order to achieve this aim the strategy outlined 3 objectives.

For each theme:			
First Objective	Direct - An objective which the Council has		
	direct control over (such as the management		
	of our buildings and operations).		
Second Objective	Indirect - An objective related to our role as		
	a Council.		

Third Objective	Influence and Partnership - An objective
	related to our potential for wider influence
	such as providing information to residents on
	actions they could take or working in
	partnership with other organisations.

- 2.4 The Action Plan 2018-19 (Appendix 1) brings together information from across the authority to monitor progress on sustainability. Specifically the Action Plan updates on progress against actions set out for 2017-18 and sets actions for 2018-19 to help achieve the aims and objectives of the strategy. The first objective in each theme area has measurable actions as these are the areas in which the authority has direct control. There are also actions associated with the second and third objectives which will be tracked over time.
- 2.5 The Action Plan shows that good progress has been made in most of the theme areas. Using a traffic light system 31 are green, 7 amber and 1 is red.
- 2.6 The DEC rating for Three Rivers House improved, however the overall greenhouse gas emissions for Council operations as a whole increased slightly. Emissions had remained the same (a fall of 0.1%) however there was a reduction in the mitigation due to the ceasing of a Green Tariff by Hertsmere Leisure in October 2016 which resulted in a net increase of 1.5% in emissions. The situation should be reversed in the 2017-18 greenhouse gas emissions reporting as Three Rivers District Council introduced a Green Tariff across all sites, excluding Hertsmere Leisure, from October 2017. Results will be reported in July.
- 2.7 Improvements in monitoring of both internal recycling and waste use is helping to raise awareness of use and the aim is to continue to improve in both these areas.
- 2.8 Unfortunately the Metropolitan Line Extension project is not currently being progressed and therefore the status for this action is red.
- 2.9 Actions set out for 2018-19 will generally look to be delivered within approved staffing and budgets but where new opportunities are identified through monitoring, which may require funding or resources, a fully costed report would be presented to the relevant committee for consideration.

3 Options and Reasons for Recommendations

3.1 To note the Action Status reported for 2017/18 and approve the Actions set out for 2018/19 in the Green Expectations Action Plan (Appendix 1).

4 Policy/Budget Reference and Implications

- 4.1 The recommendations in this report are within the Council's agreed policy and budgets. The Action Plan supports the Strategic Plan value:
- 4.1.1 'Promotes "greener" ways of delivering services, reducing the Eco-footprint of the district'
- 4.2 Specifically the Action Plan helps to achieve the Strategic Plan aims and priorities for:
- 4.2.1 'Better Neighbourhoods' by helping to 'reduce the eco-footprint of the district'.

- 4.3 The purpose of this Action Plan is to monitor delivery of 'Green Expectations' the Council's Sustainability and Climate Change Strategy, March 2015.
- 4.4 This report refers to the achievement of the following performance indicators.
- 4.4.1 EP10 Percentage of household waste sent for reuse, recycling and composting.
- 4.4.2 EP06 Tonnes of residual waste
- 4.4.3 ESD11 Greenhouse Gas emissions reported as CO2 equivalent
- 4.4.4 LL34 To maintain accreditation for Green Flag
- 4.4.5 LL32 UK Woodlands Assurance Scheme (UKWAS) accreditation

5 Financial Implications

- 5.1 None specific.
- 5.2 It is expected that any costs will be met within current budgets. Energy and water monitoring will increase awareness of use and costs should lead to savings through identification of excessive usage or leaks. In the case of a new opportunity being identified through monitoring which may require funding or resources, a fully costed report would be presented to the relevant committee for consideration.

13 Communications and Website Implications

13.1 Many of the actions require promotion of information to the public. This will require the continuation of regular articles in *Three Rivers Times*, *Environment News*, and *All Aboard*, updates to the Three Rivers and *Green our Herts* websites.
