DELEGATION OF ENFORCEMENT POWERS UNDER THE HEALTH PROTECTION (CORONAVIRUS) REGULATIONS

ADDENDUM

a) Since the drafting of the report there have been further changes to legislation in the form of an additional regulation covering the 3 tier approach/response of Central Government to the current pandemic. The new Regulations are:

The Health Protection (Coronavirus, Local COVID-19 Alert Level) (Medium), (High) and (Very High) (England) Regulations 2020 Nos. 1103, 1104 and 1105

b) It is proposed to include these additional Regulations in the proposed revised Scheme of Delegation. The (amended) proposed amendment would then read:

11.33 The Health Protection Regulations (Coronavirus)

11.33.1 In relation to:

- i. The Health Protection (Coronavirus, Restrictions) (No. 2) (England) Regulations 2020 No. 684
- ii. The Health Protection (Coronavirus, Collection of Contact Details etc and Related Requirements) Regulations 2020 No. 1005
- iii. The Health Protection (Coronavirus, Restrictions) (Obligations of Undertakings) (England) Regulations 2020 No. 1008
- iv. The Health Protection (Coronavirus, Restrictions) (Self-Isolation) (England) Regulations 2020 No. 1045
- v. The Health Protection (Coronavirus, Local COVID-19 Alert Level) (Medium), (High) and (Very High) (England) Regulations 2020 Nos. 1103, 1104 and 1105
- vi. And any other such Regulations made under the Public Health (Control of Disease) Act 1984

The officers named below are designated as authorised persons to enforce the provisions of the regulations and to issue penalty charge notices to the extent set out in the regulations. This designation includes any amendment or addition to the regulations, any regulations of similar or wider effect and any regulations that replace SI 2020/684, SI 2020/1005, SI 2020/1008, SI 2020/1045, SI 2020/1103, SI 2020/1104 or SI 2020/1105 (with or without re-enactments). Officers of Watford

Borough Council act as officers of Three Rivers District Council pursuant to the Shared Services Lead Authority Agreement and for the purposes of discharging the relevant functions of Three Rivers District Council.

Revised Recommendation

That the Scheme of Delegation to Officers contained within Part 3 of the Council's Constitution be amended in accordance with **paragraph b)** detailed in the ADDENDUM.

1 Summary

1.1 This report proposes that the Scheme of Delegation to Officers contained within Part 3 the Council's Constitution be amended to add officers authorised to carry out Enforcement under The Health Protection (Coronavirus) Regulations.

2 Details

- 2.1 Central Government has introduced a number of Health Protection (Coronavirus) Regulations which impose restrictions and requirements upon individuals and businesses. The Regulations include:
 - 2.1.1 The Health Protection (Coronavirus, Restrictions) (No. 2) (England) Regulations 2020, SI 2020/684, which came into force on 4th July 2020 and require the closure of certain businesses.
 - 2.1.2 The Health Protection (Coronavirus, Collection of Contact Details etc and Related Requirements) Regulations 2020, SI 2020/1005, which came into force on 24 September 2020 and require persons occupying certain premises to display a QR code and request contact details of individuals and groups seeking to enter those premises, and refuse entry to individuals refusing to provide such details.
 - 2.1.3 The Health Protection (Coronavirus, Restrictions) (Obligations of Undertakings) (England) Regulations 2020, SI 2020/1008, which came into force on 18th September 2020 and require certain undertakings to take measures to ensure that their customers follow the rules on social distancing.

- 2.1.4 The Health Protection (Coronavirus, Restrictions) (Self-Isolation) (England) Regulations 2020, SI 2020/1045, which came into force on 28th September 2020 and require individuals who have been notified of a positive test for coronavirus, and close contacts of such people, to self-isolate.
- 2.2 Enforcement of the Health Protection (Coronavirus) Regulations is principally by means of issuing notices (including fixed penalty notices) and, in appropriate cases, prosecution.
- 2.3 Persons authorised to carry out enforcement under the Regulations include constables, police community support officers and **officers designated by the local authority** in whose area an offence under the Regulations is alleged to have been committed.
- 2.4 For the purposes of carrying out enforcement functions under those Regulations, the following amendments to the Scheme of Delegation to Officers contained within Part 3 of the Council's Constitution are recommended.
- 2.4.1 To amend clause 11.26.11(a) to insert reference to the Health Protection (Notification) Regulations 2010, as follows:

"11.26.11(a) In consultation with the Proper Officer in relation to Infectious Disease and Food Poisoning, action under the Public Health (infectious Diseases) Regulations 1988, the Health Protection (Notification) Regulations 2010, the Health Protection (Local Authority Powers) Regulations 2010 and the Health Protection (Part 2A Orders) Regulations 2010.

2.4.2 To insert a new clause 11.33, as follows:

"11.33 The Health Protection (Coronavirus) Regulations

11.33.1 In relation to:

- i. The Health Protection (Coronavirus, Restrictions) (No. 2) (England) Regulations 2020 No. 684
- ii. The Health Protection (Coronavirus, Collection of Contact Details etc and Related Requirements) Regulations 2020 No. 1005
- iii. The Health Protection (Coronavirus, Restrictions) (Obligations of Undertakings) (England) Regulations 2020 No. 1008
- iv. The Health Protection (Coronavirus, Restrictions) (Self-Isolation) (England) Regulations 2020 No. 1045
- v. And any other such Regulations made under the Public Health (Control of Disease) Act 1984

The officers named below are designated as authorised persons to enforce the provisions of the regulations and to issue penalty charge notices to the extent set out in the regulations. This designation includes any amendment or addition to the regulations, any regulations of similar or wider effect and any regulations that replace SI 2020/684, SI 2020/1005, SI 2020/1008 or SI 2020/1045 (with or without re-enactments). Officers of Watford Borough Council act as officers of Three Rivers District Council pursuant to the Shared Services Lead Authority

Agreement and for the purposes of discharging the relevant functions of Three Rivers District Council.

3 Reasons for Recommendation

3.1 Without the appropriate designation, Council Officers cannot lawfully enforce the provisions of the Health Protection (Coronavirus) Regulations.

4.1 The recommendations in this report are within the Council's agreed policy and budgets.

6 Financial Implications

The additional enforcement responsibilities are expected to be contained within current resources with no anticipated increase in costs of the SLA with WBC. However, resources will be monitored as the situation evolves and any increase in resources will be identified through the appropriate budget monitoring procedures.

- 9.1 It is anticipated that Environmental Health Officers will take the lead in carrying out enforcement action under the Health Protection (Coronavirus) Regulations, supported by Licensing, Planning and Community Safety Officers as necessary and appropriate.
- 9.2 Where Officers of Watford Borough Council (i.e. Environmental Health Officers) discharge relevant functions within the District of Three Rivers District Council, they act as Officers of Three Rivers District Council for those purposes.

10 Public Health implications

10.1 The restrictions and requirements introduced by the Public Health (Coronavirus) Regulations are intended to protect against the risks to public health arising from coronavirus.

11 Risk and Health & Safety Implications
