7. THREE RIVERS DISTRICT COUNCIL PLAY AREA – CAPITAL UPGRADING PROGRAMME 2024 – 2033

DCES

1 Summary

1.1 The purpose of this report is to provide Members with proposals for the future priority order for upgrading and refurbishing play areas in the District.

2 Details

Previously agreed programme 2021 - 2024

- 2.1 Members have previously agreed a capital upgrade programme for Leisure facilities from 2021 2024 at the Leisure, Environment and Community Committee meeting of 11 July 2018 (minute note: LEC 07/18).
- 2.2 The following table shows the previously agreed programme for 2021 2024:

- 2.3 Play areas across the district have been successfully upgraded since 2008, providing a variety of high quality play areas for all local communities. Continued investment is required to keep the district's play areas at a high standard and to ensure that all equipment and surfacing meets the required British Standards (BS EN 1176 and BS EN 1177).
- 2.4 As part of the British Standards in playground safety, play areas must have an annual inspection, completed by a Registered Play Inspector. Officers review these annual inspections and carry out the required recommendations for each play area contained within the report. These reports also consider the life expectancy of the play areas.
- 2.5 The table detailed at 2.9 is the suggested programme for 2024 2033, taking into account the annual inspection recommendations, as well as the timetable in which they were originally upgraded.
- 2.6 Most play areas across Three Rivers remain at a high standard and therefore the recommendations are to split the budget across two sites each year as they do not require whole play area upgrading. The exceptions to this will be in the years it is recommended to carry out a General Upgrading of play areas, as well as for two of the older, larger play areas, where the full budget will be required to carry out the upgrade.
- 2.7 The General Upgrading programme will take into account some of the higher priority recommendations from the annual inspections and will be across a number of sites in the district.

2.8 The following table shows the previously agreed play area and outdoor fitness zones upgrading programme from 2022 – 2023:

- 2.10 Officers will also look to source additional funding to support the projects outlined as well as working with the appropriate Parish/Community Councils as and when required.
- 2.11 Officers would recommend finalising a service level agreement with the appropriate Parish/Community Council, where projects are jointly delivered.

3 Options and Reasons for Recommendations

3.1 The purpose of this report is to provide Members with proposals for the future priority order for upgrading and refurbishing small leisure capital facilities in the District.

4 Policy/Budget Reference and Implications

- 3.2 The recommendations in this report are within the Council's agreed policy.
- 3.3 The proposed recommendation will impact on the following key performance indicators:
 - CP02 Satisfaction with Parks and Open Spaces
 - C022 Satisfaction with sports and leisure facilities
 - LL34 To maintain accreditation for Green Flag
 - LL31 Number of attendances by adults at leisure venues and activities
 - LL33 Number of attendances by young people at leisure venues and activities
- 3.4 The proposed recommendation will impact on the following service performance indicators:
 - CP24 Number of adults achieving 30 minutes of physical activity per week
- 3.5 The impact of the recommendations on this/these performance indicator(s) is:
 - 1. To support the Council in achieving these performance indicators by providing clean, safe and well maintained parks and open spaces for people to use and enjoy for a variety of reasons: play, recreational, health and wellbeing, environmental etc.
 - 2. By providing positive activities for children and young people, which support their own physical and mental health and wellbeing
 - 3. In order to achieve Green Flag status, the site must demonstrate a variety of uses by different community groups.

4 Financial Implications

4.1 Members have previously agreed £100,000 for "Improving Play Areas – Future Scheme" since 2013. Officers therefore propose that this funding be utilised for the priority order detailed in 2.10.

- 4.2 Should any additional funding be required, an application for this will be submitted as part of the budget setting process.
- 4.3 Play areas have an annual revenue budget allocated to them for ongoing maintenance. However, as play areas have increased in number, size, style and popularity, there is likely to be a future requirement to increase the management and maintenance of these sites. Therefore, these may require future growth bids and these will be included in the Environmental Protection Service Plan and considered as part of the budget setting process.

5 Legal Implications

- 5.1 All proposed works will be tendered within the Council's constitution and procurement procedures.
- 5.2 All projects must have a post installation inspection carried out by a Registered Play Inspector and all play areas must meet the British Standards: BS EN 1176 and BS EN 1177.

Play facilities and outdoor fitness zones are open access and free to the public to use. Local residents will be consulted as part of the upgrading and refurbishing play area programme, including those with a disability and inclusive equipment included within each site.	

7 Staffing Implications

- 7.1 The play area and outdoor fitness zones capital programme will require the time of the Landscapes and Leisure Development Manager, Projects Development Officer, external Principal Designer and Project Manager to oversee project management, consultation, negotiations and installation of the new facilities.
- 7.2 The maintenance of play areas and outdoor leisure facilities will be managed and overseen by Environmental Protection.

8 Environmental Implications

- 8.1 The installation of new leisure facilities across the District will increase the quality of provision of community facilities in the public open spaces.
- 8.2 The new facilities will aim to make use of natural materials as well as recycled materials. The designs will be sustainable and will include sustainable features where possible. The users of the children's play area will be encouraged to appreciate the natural surroundings as part of the play experience.

- 8.3 The procurement specification will required the tendering contractor to provide evidence of their own approach to sustainability and will be scored accordingly as part of the tender evaluation.
- 8.4 This will support the Council's Sustainability and Climate Change Strategy.

9 Community Safety Implications

- 9.1 The local Police Community Safety Officers, Crime Prevention Liaison Officer and the Grounds Maintenance team will be consulted on the final design options for all sites.
- 9.2 The installation of new leisure facilities will provide the opportunity for children and young people to take part in positive activities.

10 Public Health implications

- 10.1 Accessible, well maintained parks and open spaces have never been more vital to the health and wellbeing of individuals than during the COVID 19 Pandemic.
- 10.2 Providing free, accessible play facilities will encourage children and young people to be physically active, and will support the achievement of the Council's Physical Activity Strategy.
- 10.3 It will also provide a point for families to meet and socialise, supporting mental wellbeing and the priorities of the Hertfordshire Health and Wellbeing Strategy.
